The Department of the Army respectfully submits this letter to serve as notification to the New Mexico Environment Department, Hazardous Waste Bureau (NMED-HWB), that on March 15, 2024, the Navajo Nation and The Zuni Tribe received the above-mentioned report for review and comment. The 60-day Tribal review period for that document expired on May 31, 2024, and the Army has not received comments from either Tribe about this report.

Pursuant to our agreement, NMED agreed to provide a response to the Army regarding the Report only after the Army demonstrated that it had reviewed and responded to Tribal comments. With the expiration of the review period without comments, the Army assumes the Tribes have no comments.
